## Our Commitment to Community Health

Founded over a century ago as a single hospital in Danville, Pennsylvania, Geisinger now provides the highest quality healthcare services to communities throughout central and northeastern Pennsylvania. Our nonprofit mission is to not only meet the immediate healthcare needs of the people in the communities we serve, but to anticipate, identify, and address future health issues and trends.

The Community Health Needs Assessment (CHNA) helps us do that. Every three years, we conduct a thorough, formal process to identify the specific needs of the communities and regions we serve and then develop meaningful, measurable responses.

Geisinger's integrated healthcare system has become a nationally recognized model of care delivery. Our goal is to help people stay well, not just through clinical treatment and positive patient experiences, but also through education and programs that can help them prevent or manage disease and live healthier lives. Funding and supporting activities, programs, and services that benefit those who live in our service area is a big part of what we do.

By providing support to our local communities, identifying much-needed services, and establishing partnerships with community-based organizations, we can improve the physical, social, and mental well-being of those we serve.

# 2024-2026 Community Health Improvement Plan

## What is a Community Health Improvement Plan (CHIP)?

A CHIP helps organizations move from data to action to address priority health needs identified in the CHNA. The CHIP serves as a guide for strategic planning and a tool by which to measure impact by detailing goals, objectives, strategies and action steps over the three-year reporting timeframe. Anchoring initiatives and community benefit activities to measurable objectives, the CHIP creates a framework for measuring the impact of our initiatives.

## Community Input

Like the CHNA, the CHIP reflects input from diverse stakeholders and helps to foster collaboration among community-based organizations. Community health priorities for Geisinger were identified with feedback from community stakeholders, including historically underrepresented and underserved populations, health and social service providers, and community health experts. These individuals provided input to define and recommend solutions to improve health in our communities.

## Determining Community Health Priorities

It is imperative to prioritize resources and activities toward the most pressing and cross-cutting health needs within our community. In determining the issues on which to focus efforts over the next three-year cycle, Geisinger collected feedback from community partners and sought to align with community programs, population health management strategies, and health equity initiatives.

In defining the 2024-26 priority areas and developing its CHIP, Geisinger outlined a systemwide approach mirrored in its vision to make better health easy, and that centers strategies to advance health equity and address social drivers of health (SDoH). *Hospital specific Implementation Plans that reflect this systemwide CHIP and the unique strengths and assets of our diverse communities are available for each Geisinger hospital.*

## Priority Area: Access to Care

**Goal:** Empower our communities to be well by removing barriers to healthcare.

- ▶ **Objective:** Increase the number of residents who receive regular primary care services.
  - ▶ **Systemwide Strategies:**
    - Assist with eligibility determination and enrollment in available health insurance programs.
    - Conduct point of care primary care screening and scheduling assistance within the Emergency Department and other outpatient settings.
    - Expand primary care services including access to Geisinger 65 Forward Health Centers and CommunityCare sliding fee health services.
    - Cultivate trusting and inclusive care environments that promote healthcare access for diverse populations.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Expand the Geisinger at Home, Care Coordination and Integration programs to provide primary care provider visits via mobile and audio-visual technology to the high-risk and homebound population.
    - Explore options and partners to provide home-based care services (mobile integrated health, home health agencies, Geisinger at Home, etc.).
- ▶ **Objective:** Increase access to primary and specialty care services in underserved communities.
  - ▶ **Systemwide Strategies:**
    - Provide or sponsor sliding fee programs for individuals without health insurance and/or with low incomes.
    - Provide mobile and home- and community-based services that bring care to residents.
    - Seek out partnerships and strategic opportunities to develop or augment care environments in underserved communities.
    - Expand access to quality telehealth including age-inclusive telehealth for older adults.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Explore telemedicine options to provide services and reduce barriers to care related to transportation.
    - Expand access to primary care through growth in legacy Community Medicine sites and new locations to include 65 Forward, ConvenientCare, ConvenientCare+, and Community Care.
- ▶ **Objective:** Increase the available healthcare workforce and advance diversity of talent.
  - ▶ **Systemwide Strategies:**
    - Partner with school districts, universities, and other youth service providers to foster healthcare career pathways.
    - Collaborate with schools of medicine, nursing, and other health professionals to foster careers in needed health services and recruitment for underserved areas.
    - Embed inclusive practices and processes into how we attract, recruit, retain, and advance a diversity of talent.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Offer cohort program in multiple specialties appealing to high school students.

- Strong participation in local career fairs targeting high school students.
- ▶ **Objective:** Reduce disparities in healthcare access.
  - ▶ **Systemwide Strategies:**
    - Increase collection of REaL, SOGI, zip code, and other demographic data in order to better understand and address disparities.
    - Leverage local trusted people, places, and methods to expand healthcare services for diverse populations.
    - Provide qualified language services to meet the diverse and preferred language needs of patients.
    - Support Neighborly online platform and other resources to increase awareness of available services to meet social drivers of health needs.
    - Seek out partnerships and strategic opportunities with community-based organizations to coordinate referrals and collectively address social drivers of health barriers.
    - In partnership with Geisinger Health Plan, help address healthcare transportation barriers.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Provide DEI education to front line care givers to improve knowledge of appropriate communication for all individuals who present to GWV/GSWB.

## Priority Area: Behavioral Health

**Goal:** Improve behavioral health by fostering communities and care environments that promote wellness, recovery, and resilience.

- ▶ **Objective:** Reduce disparities in behavioral health and wellbeing.
  - ▶ **Systemwide Strategies:**
    - Strengthen and support community initiatives that foster youth resilience (e.g., mentorship, career development, social emotional learning opportunities).
    - Provide trauma sensitive training, including identifying and supporting individuals with adverse childhood experiences (ACEs), in clinical and community settings.
    - Support and promote efforts to raise community awareness of behavioral health.
    - Invest in community initiatives and infrastructure that promote resident engagement and sense of community.
    - Increase collection of REaL, SOGI, zip code, and other demographic data in order to better understand and address disparities.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Medication-assisted Treatment (MAT) clinic available at GSWB allowing for broader access to reversal drugs.
    - Host community Narcan event to provide free Narcan and educational opportunities.
- ▶ **Objective:** Increase access to and capacity of behavioral health services.
  - ▶ **Systemwide Strategies:**



- Partner with community-based organizations to assess behavioral health needs, facilitate service referrals, and coordinate care.
- Implement universal behavioral health screenings in care settings.
- Provide community-based substance use prevention and treatment options (e.g., medication take back programs, Narcan distribution, Free2BMom).
- Seek out partnerships and strategic opportunities to develop or augment care environments in underserved communities.
- In partnership with the Geisinger Commonwealth School of Medicine’s Behavioral Health Initiative, increase integration of behavioral and physical healthcare.
- ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
  - Partner with Geisinger Behavioral Health Northeast for appropriate access to inpatient care.
  - Continue to grow access to outpatient behavioral health services (telemedicine).
- ▶ **Objective:** Increase access to recovery-oriented care and recovery support systems.
  - ▶ **Systemwide Strategies:**
    - Increase participation of people with lived experience in care development and delivery.
    - Partner with community-based organizations to assess recovery needs and strategic opportunities to enhance recovery options.
    - Support and promote recovery support groups and other activities.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Develop a certified recovery specialist program in the GWV ED to support patient and recovery provider pathways.

## Priority Area: Chronic Disease Prevention and Management

**Goal:** Manage total health from coverage and prevention to care and treatment.

- ▶ **Objective:** Reduce risk factors for chronic disease.
  - ▶ **Systemwide Strategies:**
    - Invest in community initiatives and infrastructure that promote a healthy built environment.
    - Provide community-based access to early screening and detection services and health promotion programming.
    - Leverage local trusted people, places, and methods to expand prevention services for diverse populations.
    - Support Neighborly online platform and other resources to increase awareness of available services to meet social drivers of health needs.
    - Seek out partnerships and strategic opportunities with community-based organizations to coordinate referrals and collectively address social drivers of health barriers.
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Support various community health and wellness educational programs.
    - Promote and support the Geisinger Fresh Food Farmacy, including diabetes wellness classes and dietary consultations, to food-insecure, diabetic patients.
- ▶ **Objective:** Reduce disparities in chronic disease outcomes.
  - ▶ **Systemwide Strategies:**
    - Increase collection of REaL, SOGI, zip code, and other demographic data in order to better understand and address disparities.
    - Provide coordinated care programs for individuals with complex medical conditions and/or at risk for disease complications.
    - Provide self-monitoring and self-management tools and programs to empower individuals to manage their condition(s).
  - ▶ **Geisinger Wyoming Valley Medical Center & Geisinger South Wilkes-Barre Tactics:**
    - Provide evidence based medical nutrition therapy for patients at Geisinger 65 Forward and Geisinger Federally Qualified Health Centers (Kistler and Hazleton).

## Community Commitment and Collaboration

The 2024 CHNA report was presented to the Geisinger Board of Directors and approved in November 2023. The corresponding three-year Community Health Improvement Plan for the system was presented to the Geisinger Board of Directors and approved in February 2024. *The systemwide CHIP strategies will be implemented with hospital-specific tactics that recognize the unique strengths and assets of our diverse communities.*
