Personal Career Summary

I am a senior epidemiologist and leading behavioral scientist who has focused on behavioral health, chronic disease epidemiology, neuropsychiatric research, and on veterans' health studies. Working in both the contract and academic research environments for over 35 years, I have directed over 1,000 studies related to addictions. posttraumatic stress disorder, chronic pain, HIV disease, chronic hepatitis, rheumatoid arthritis, and patient satisfaction. Currently, I am currently the PI for a study of mental disorders, traumatic brain injury, suicide risk, and treatment seeking among formerly deployed National Guard and Reserve service member seen in non-VA facilities, funded by the Department of Defense (DoD) and Site PI for a national study of opioid misuse among patients treated with extended-release/long acting opioids funded by the FDA. I am also the site PI for the Fibrotic Liver Disease Study (FOLD) (funded by Intercept Pharmaceuticals) and the Addiction Research Network (ARN) (funded by NIDA), both associated with the Healthcare Systems Research Network (HCSRN), a national network conducting population-based studies with electronic health records, surveys, and patient registries to develop innovative approaches to clinical research. I am also the site PI for the Chronic Hepatitis Cohort Study funded by the CDC since 2007 (also with the HCSRN). My current research portfolio includes assessing the health impact of PTSD among trauma, warzone, and disaster victims, on studying the risk factors for PTSD, addictions, and other mental health disorders. In addition, I am also investigating the role of PTSD in the onset and course of inflammatory diseases, including ischemic heart disease and rheumatoid arthritis. Furthermore, with NIH funding, I have developed the next generation of PTSD risk assessment tools using the World Trade Center Disaster Study and other trauma data. My research team also evaluated the health impact of Hurricane Sandy at the Jersey Shore in collaboration with a healthcare system in Monmouth and Ocean County, New Jersey. Finally, I am also investigating key risk factors for suicide, including assessment of genetic risk factors. I currently hold adjunct appointments at Mount Sinai School of Medicine (Pediatrics and Internal Medicine) and at Temple University School of Medicine (Psychiatry). In 2009, he was elected to Fellow Status by the American Psychological Association (APA) for my psychological trauma research; in 2010 I was given a Lifetime Achievement Award by the International Society for Traumatic Stress Studies (ISTSS) for my World Trade Center disaster and veterans' research programs. In addition to the APA and ISTSS, I am also a member of the American College of Epidemiology, American Psychosomatic Society, and the Society of Biological Psychiatry. In 2012, I was appointed to serve as a committee member on the SHAD-II Veterans Study by the Institute of Medicine (IOM). The purpose of this effort was to assess the health effects of exposure to chemical and biological weapons among naval personnel during the Cold War. In 2014, I was awarded the Charles Shepard Science Award for Research Methods, by the CDC, Atlanta, GA, for my chronic hepatitis research. Over the past 35 years, I have also served as a grant reviewer for the HSR&D and Epidemiology Services of the VA, Washington, DC, for the US Army Materials Readiness Command, Fort Detrick, MD, and for NIH. To date, I

GEISINGER CLINIC (Danville, PA; 12/2005 - Present). As a Professor with the Geisinger Clinic, has received research funding from NIH, FDA, CDC, AHRQ, DoD, PA Department of Health, foundations, pharmaceutical industry, among other sponsors. With NIH funding, currently developing the next generation of posttraumatic stress disorder (PTSD) risk assessment tools using the World Trade Center Disaster Study and other trauma data (R01-MH-066403; R21-MH-086317, Boscarino PI). The goal of this research is to develop prediction models that can be used in clinical practice to predict the onset and course of PTSD. The latest version of this prediction model also includes genetic risk information (see: Boscarino et al. Predicting PTSD using the New York Risk Score with Genotype Data. Neuropsychiatric Research & Treatment. 2013; 9: 517-27). Currently developing a "risk score" approach for predicting opioid addiction in medical settings using this same method. Also currently assessing the risk for PTSD and mild traumatic brain injury (mTBI) among adults exposed to traumatic events. For this study, patients who were discharged from Geisinger's Trauma Center are being studied. DSM diagnostic instruments are being used for these interviews. In addition, also conducting investigations related to the genetics of drug dependence, alcoholism, and suicide. This research is assessing the genetic and environmental risk factors for these disorders, including the impact of exposure to early childhood trauma. Currently, 35 genetic variants are being studied, including brain-derived neurotrophic factor, catechol-O-methyltransferase, corticotropin releasing hormone, dopamine receptors (DR1, DR2, DR3, DR4), monoamine oxidase A, neuropeptide Y, opioid receptor - mu 1, serotonin transporter, and nicotinic receptor genes, among others. Also conducting research related to assessing the health status of deployed warzone veterans, with funding from several sponsors, including DoD and NIH. In addition, as the Geisinger site PI, currently directing a prospective cohort study of chronic hepatitis infection for the CDC. This study is one of the largest chronic hepatitis studies in the US and is being conducted in collaboration with other HMO Research Network sites. In 2014, was awarded the Charles Shepard Science Award for Research Methods, by the CDC, Atlanta, GA, for this hepatitis research. Also studying the health impact of biologic medication usage on rheumatoid arthritis outcomes at Geisinger with funding from private industry. In 2012, was appointed to the Institute of Medicine, National Academy of Sciences, as a Committee Member for the SHAD-II Health Study. This study represents a 50-year follow-up study of Navy veterans exposed to chemical and biological weapon experiments during the Cold War. In addition, recently investigated the health impact of exposure to Hurricane Sandy at the Jersey Shore among trauma-exposed adults in Monmouth County, New Jersey. Finally, served on the Geisinger IRB from 2007-2010 and was the Director of Clinical Research Training at Geisinger from 2007-2014.

NEW YORK ACADEMY OF MEDICINE (New York, NY; 8/2001 – 12/2005). As a Senior Scientist with the New York Academy of Medicine (NYAM), conducted research on patient safety, the health impact of the World Trade Center disaster (WTCD) in New York City, and on healthcare service needs in primary care. In addition, also assessed the long-term health impact of Posttraumatic stress disorder (PTSD) among Vietnam War veterans. Finally, provided clinical research and statistical support for the Department of General Pediatrics at Mount Sinai School of Medicine (MSSM). The WTCD project included a prospective epidemiologic study of ~2,400 New York City residents. The quality improvement and patient safety research included a study of 1,500 adults in NY State related to use of healthcare information in medical decision-making. Healthcare provider studies conducted included a survey of 1,400 pediatricians in NJ, NY & CT, a study of 250 mental health professionals who provided mental health services after the WTCD, and a study of several hundred pediatricians designed to assess practice changes/needs in primary care after the WTCD. The veteran studies conducted included a 30-year follow-up of 15,300 veterans exposed to traumatic stressors during the Vietnam War. Combined these projects represented a \$3,000,000+ research portfolio, with funding provided by the National Institute of Mental Health, Robert Wood Johnson Foundation, New York State Office of Technology Assessent, American Red Cross, Mount Sinai School of Medicine, and other sponsors.

MERCK & COMPANY – Medco Division (Franklin Lakes, NJ; 12/1998/01/2001). As a Senior Director, led the Outcomes Research Team for Merck-Medco's Clinical Analysis and Outcomes Research Department. Designed and implemented research for pharmacoeconomic and pharmacoepidemiologic studies, based upon existing programs or ad hoc studies required by Merck-Medco's business requirements. Monitored data collection and coordinated analyses assessing the impact of interventions on health, patient safety, economic, and drug use outcomes.
